Competition Terms and Conditions

Article 1: Organising Company

The company VICE, located 75 Boulevard Macdonald, 75019, organises a competition called "" on behalf of the company Boucheron SAS, a simplified stock corporation capitalised at 2.000.000,00 Euros with an office located 26, place Vendôme – 75 001 Paris, and registered with the Registry of Commerce and Parisians Companies "*Registre du Commerce et des Sociétés de Paris*", under the number 330 160 367 (hereafter "the organising body").

By taking part in this competition, participants accept fully and completely. The present terms and conditions and its application by the organising body.

Article 2: Conditions of Participation

This competition is open to any adult individuals, based in France Metropole, with access to the internet and an email address; expect from employees and direct relatives working for any of the companies having participated directly or indirectly to the organisation and production of this competition.

Participation to this competition is free and without any obligation to purchase. It is limited to one participation per person (one email) during the whole duration of the competition.

In the case of multiple entries, all participations of the person involved will be rejected and considered as void.

They will have to register by filling out a form. During the registration, participants will have to complete all the compulsory fields. In order to validate their participation to the competition, each participant will have to include three other email addresses. Any postal address will be voided.

The organising body retains the right to carry out all the verifications it considers necessary as regards to the identity and email addresses of the participants.

Participants who haven't given the means to verify their personal details and given their full identity, or given out false or incomplete information, will be disqualified. Article 3: Time frame of the competition

Article 4: Choosing Competition winners

Article 5: Prizes

The winners will be announced after a thorough check of their eligibility to the prize.
